NOTE TO RATEPAYERS MAKING A RATE ARRANGEMENT TO PAY OFF OVERDUE RATES BY INSTALLMENTS

South Burnett Regional Council ('Council') is normally willing to accept any reasonable offer to pay rates off by instalments as long as the proposed regular payments are maintained, and they will clear the outstanding rates before the end of December or June following the issue of the relevant rate notice.

Ratepayers are reminded that the prompt payment discount (payment within the 30-day discount period) is forfeited. Under the provisions of the *Local Government Act 2009*, outstanding rates will accrue daily compound interest at 8.17% per annum (charged monthly) until paid in full, or until a rate arrangement application is submitted and approved. Therefore, it is in your interest to clear the debt as quickly as possible.

However, provided that you maintain regular payments at the agreed times, interest will not be charged.

Council does not issue 'reminders' to ratepayers to advise when the next part payment is due. It is your responsibility to make sure your part payment is made on time. If a part payment is not received as promised, Council will send you a letter seeking an explanation as to why your payment was not made together with a request for the immediate payment of the 'missed' part payment. **Note: Interest charges will restart from the business day after your part payment was due**.

If you are unable to make a payment at any time, or your circumstances change, please contact the Rates Section immediately, so that alternative arrangements for payment can be made. If three (3) consecutive payments are missed, then Council will **cancel** the arrangement and may commence recovery action **immediately** to collect the outstanding rates.

How can I pay my part payments?

Pay in Person

At any South Burnett Regional Council Office (between 8.30am and 4.30pm Monday to Friday) EFTPOS available

Contact your bank, credit union or building society to make this payment from your cheque, savings or credit card account

Centrepay

A free service for Centrelink customers to pay bills as regular deductions from their Centrelink payments. Minimum payments apply. Subject to Council approval. Contact Council's Rates Section or Centrelink for more information.

<u>Interest</u> – As stated above, provided that you continue to make your part payments as promised, Interest will not be charged. However, if you fail to make a payment as promised, interest charges recommence from the business day after the part payment was due.
