Acknowledgement

I/We acknowledge that the election signage being displayed at the above mentioned places will be in accordance with *Subordinate Local Law No 1.04 (Installation of Advertising Devices) 2011*, Schedule 3(26)(2). Specifically the election signage will:

- a) not have a face area in excess of 1m²; and
- b) not be displayed on a local government controlled area or a road; and
- c) not be displayed unless, prior to the display of the advertising device, the advertiser for the advertising device has given written notice to the local government of the place at which the advertising device will be displayed; and
- d) if the advertising device is about a government election - be removed by the advertiser for the advertising device within 7 days of the date of the government election.

I/We agree to meet the criteria in *Subordinate Local Law No 1.04 (Installation of Advertising Devices) 2011*, Schedule 3(26)(2).

I/We agree to advise Council when all the election signs displayed have been removed (within the 7 days of the date of the government election) to request a refund of the security deposit paid.
