Social Corporate Performance:

Planning with our Community for the future of our region

Last month, my fellow Councillors and I completed an intensive induction program led by our Chief Executive Officer, Mark Pitt. We are very grateful to Mark and his staff for the timeliness and quality of the information shared. The program provided our newly elected Council with a detailed understanding of the operations of the Council as well as our roles, responsibilities and obligations to the some 33,000 people living within our region. Pursuant to such, our new council has committed to working diligently over the next four years in becoming a model council in applying the local government principles. In conversations with the people of our region over the past 9 months, they have made it clear that their expectations of their council are very much consistent with these principles.

These governing principles, to which the people of the South Burnett are entitled, include:

- transparent decision-making, at all times in the broader public interest;*
- democratic representation, social inclusion and meaningful community engagement;*
- ethical and legal behaviour of councillors and local government employees.*

Our new council has had extensive early discussions in relation to the issues raised by our community during the election process. It is evident from these discussions, that within coming months, we will need to work actively with our communities to re-write our 5-year Corporate Plan. This is necessary to strengthen Council's connection to community and ensure we are developing and managing our communities assets sustainably and delivering the services that the people of our region deserve in an efficient, effective and most importantly, accountable manner. Our pledge to the people of the South Burnett, is that, in re-writing our Corporate Plan will ensure that Council consults extensively across individual towns and villages, farms and industry, to ensure that the Corporate Plan is indeed, the peoples plan. At the end of this process, the result will be a plan for the South Burnett that provides direction from the community, to Councillors and staff in working over the next 5 years to create a more prosperous and sustainable future for all people across our region.

Development of the Operational Plan 2020/2021

Over recent months, Council has been reviewing and examining data in preparation for the development of the 2020/2021 operational plan. Our task, as a regional local government, in developing our operational plan is to ensure we are providing our communities with essential services and balancing priorities in an economically responsible manner over the course of the next financial year.

In pursuit of such, we will need to act carefully and responsibly, with the health, social and economic impact of Covid-19 in the forefront of our minds.

Over the coming weeks, Council will provide information to the community to assist in their understanding of what Council plans to deliver during 2020/2021.

People and Culture:

Culture and Engagement

A strong effort has been made over the last 8 weeks to engage with all staff as to suitable work arrangements during the current pandemic. Job security and community safety has been the priority of the People and Culture Team in ensuring that the business of council continues without jeopardising the health and well-being of our people.

Workplace Health and Safety

WHS statutory training has in some instances been held up due to the current situation with COVID-19, some license renewals are being held over by the State. Internal training is also being utilised where possible.

Workplace Relations

We are pleased to see that Officer and Field Staff Collective Agreements have now received a successful vote. Application documents are progressing to the Queensland Industrial Relations Commission (QIRC) for certification of the two Collective Agreements. Our sincere thanks go to everyone involved in the process for your patience and co-operation.

In April, Council made 72 facebook posts with the most popular post being 'COVID-19 update' of 1 April reaching an audience of 8,477. Council's 'southburnettregion' facebook page ended the month with 7541 likes and 7442 followers.

Council purchased two full page ads in the South Burnett times during April, reaching an estimated audience of 9,200 and published 3 classified public notices in the same publication.

The first of Council's mayoral press conferences was held after the 29 April ordinary meeting, with attendance from The Martoo Review, the South Burnett Times and South Burnett Online.

Council and the Media Team are committed to implementing a strong communication and media strategy over the current term of council in the interest of ensuring the community are kept informed in an open and transparent manner.

Finance:

The monthly report illustrates the financial performance and position of South Burnett Regional Council compared to the proposed third quarter budget, at an organisational level, for the period ended 30 June 2020. This financial report is prepared based on interim financial results as at 30 April 2020.

Overall, recurrent revenue is tracking high at 91% due to the rates being levied in February and the timing of the rates write offs which will be processed in the next month.

Fees and charges and rental income are also tracking high at 99% and 97% respectively due to the timing of applications and annual invoices/ registrations. Due to the impact of COVID-19 on the economy we do not anticipate receiving any more substantial fees and charges by 30 June 2020.

Overall, recurrent expenditure is tracking on target at 83%. Materials and Services is tracking high at 86% mainly due to the timing of end of year provision adjustments and the credit for the adjustment in KPMG fees relating to the fuel tax credit claim. There are also a number of annual invoices that have been paid. This will be monitored by finance through to year end.

Finance costs are still tracking slightly low at 63% due to the number of end of year adjustments that will be performed at 30 June 2020, including landfill and gravel provisions.

It should be noted that:

- Whilst Depreciation is tracking on target, the processing of WIP and disposals remains underway for Roads, Fleet and ICT which may impact the final year-end balance.
- Employee benefits is tracking on target however the amount of capitalised wages, end of year adjustments and EB negotiations will affect the final June numbers.
- Cash and Cash Equivalents are sitting at \$46.6m. This is high due to the rates discount ending last month. This balance will decrease over the next few months as revenue streams reduce to a minimum.

AR Debtors 90-day balance has significantly reduced this month with the Niagara Road Project payments being drawn down from Trust. While debt collection has been temporarily suspended due to the impact of COVID-19 outstanding debts are still being monitored and followed up internally.

Rate in arrears is currently \$7.263m or 12.8%. This has again decreased since the previous month.

The current monthly ratios are tracking on target, except for the operating cash ratio, which is sitting above the target benchmark. This is due to the spike in trade and other receivables from the February rate run.

Of the total available capital budget of \$37.4m, 70% has been spent to date including committed costs.

Road maintenance has increased approximately \$677k from March to a total actual and committed cost of \$5.404m.

Works for Queensland has \$3.078m of actuals to date with a further \$809k in committed costs. The next milestone claim has been submitted with the \$1.8m expected to be received within the next month.

The external audit plan has been finalised and Council's first interim audit is currently underway with auditors commencing their first interim audit remotely on 27 April 2020. The next visits are scheduled for May and September 2020.

Council is in the process of preparing the 2020/21 budget. Councillors and staff will continue to invest many hours over coming weeks in working through the budget in detail.

Community:

Libraries

South Burnett Libraries Closure

Following instruction from the Federal and State Government, all South Burnett Library branches closed on 25 March 2020. Prior to this, loans per membership account were increased to 20 to allow library patrons the chance to stock up on reading material. Behind the scenes, all customer's reservations were suspended and all items on loan renewed until 1 June 2020. This has since been extended until 31 July 2020, ensuring that customers will not receive overdue notices or charges due to the closure of our libraries.

Library Reopening

From Monday 25 May 2020, South Burnett Libraries will reopen to the public with limited numbers as per government guidelines. Library staff have been consulting with Council's People & Culture team, with risk assessments completed by Council's Workplace Health & Safety department to identify and problem solve the potential risks for reopening. A maximum of 10 customers in each branch at any one time will be permitted to return and borrow items available on the shelf. Perspex screens will be in place at each library service counter, with customers able to sanitise their hands using the newly installed sanitisation stations provided by Council. Returned items will remain in a dedicated quarantine area in each library for a period of at least 24 hours before they are handled by staff and put back into circulation. Furniture and computer facilities have been rearranged to meet social distancing requirements, and whilst bookings for public access computers will be available, each session will be limited to 15-30 minutes. Regular cleaning of communal spaces will be undertaken by staff, with wipes available for customers if needed. Extended loan limits will remain in place, with 20 items per membership card allowed. Reservations and Inter Library Loans will not be reinstated at this stage.

Library Staffing

Anna Derham, South Burnett Libraries' Regional Librarian, retired on 30 April 2020. Council thanks Anna for her contribution to the service and wish her every happiness as she begins this next step in life.

Recently, Jane Gunn became the South Burnett Libraries' First 5 Forever program co-ordinator. Jane brings with her a wealth of library knowledge, having worked in a similar role with Gympie Regional Libraries.

During the COVID-19 closure, staff working in the library have been cleaning and re-shelving items as they are safe to do so, whilst contributing online content in the form of library resources and collections reviews. Staff have also been assisting Council's Disaster Management Team and other Council departments, whilst some staff elected to take leave.

South Burnett Libraries Online

To meet a rise in demand for online content, South Burnett Libraries purchased additional online resources. Initially, the library focussed on the eBook and eAudiobook collection to ensure new content was readily available. The Story Box Library, which features a range of actors, authors and

illustrators reading well know picture books aloud was purchased to meet the community's early literacy needs. Beamafilm, an online movie streaming service, was purchased to increase access to free movies from home. In addition to this, South Burnett Libraries purchased an electronic magazine platform called RB Digital. This is the first eMagazine collection for South Burnett Libraries; it allows simultaneous magazine borrowing from the comfort of your own home.

The library is offering over the phone support for members of the community who may need assistance connecting to the library's online resources. The library has also produced a number of "How to" video tutorials which have performed well on the South Burnett Libraries Facebook page. Overall, the page reach has increased by 424%, with 11,373 people seeing posts from our service. In terms of tech support, the library has created a series of simple tech videos that deal with issues including eSafety for children, how to spot a potential scam and online shopping.

First 5 Forever

South Burnett Libraries First 5 Forever programming crossed the digital divide, with Jess and Jane recording and posting a series of online story times. These videos aim to keep rhyme time and story time attendees connected with library staff and programs. Jane has also been contributing content to the 4610 Partnership for Kids group.

Sport & Recreation:

I attended my first Wide Bay Burnett Regional Sport & Recreation Advisory Committee meeting on 7 May with Council staff via skype, where I was nominated and endorsed as the Committee Chair. Discussions were held around how everyone is dealing with COVID-19 restrictions and the effect it has had on local sporting clubs and available funding opportunities.

The Department of National Parks, Recreation, Sport & Racing (NPRSR) advised that the Queensland Health, Education, Sport and Recreation are currently collaborating to design a state wide implementation of the Australian Institute of Sport Framework for rebooting sport in a COVID-19 environment.

Health and Wellbeing Queensland launched a new digital hub (Boost your health during COVID-19), designed to provide support, inspiration and ideas to help Queenslanders stay healthy and active during COVID-19. It features content from a wide range of Alliance Partners including a series of fitness challenges as set by some of Queensland sporting greats.

(NPRSR) advised the clubs that were successful under the Active Clubs Grant have been notified that eligibility has been extended to fund operational costs (as a COVID one-off).

The Active Community Infrastructure program (EOI) that South Burnett Regional Council applied for in March has been put on hold at present.

(NPRSR) are in the process of contacting Local Governments about how sports organisations can be supported under the COVID-19 situation. This project team will be headed up by Anna Barrett.

Council's Sport & Recreation staff are continuing on-going community consultation and assistance and have been working with the Blackbutt Sporting Clubs (rugby league, touch, cricket and athletics) with facility assessments and future funding opportunities, Kingaroy Sporting Clubs (soccer, touch, rugby league and AFL) on future development plans and funding opportunities and with Nanango Sporting Association with facility assessment and funding options.

Weed Control

Pest Management contractors and staff treated 55 hectares of restricted, environmental and infrastructure spraying during April including;

Giant Rats Tail Grass – Hivesville, Blackbutt, Mt Stanley and Runnymede

Parthenium – Murgon

Annual Ragweed – Benarkin

African Boxthorn – MP Creek, Stonelands, Wondai

Splatter guns were loaned to landowners at Kumbia, Brooklands, Ellesmere, Mt McEuen and Burrandowan.

Trailers were hired out at Woorooden and Memerambi for Giant Rats Tail Grass control and Cobbs Hill and MP Creek for Lantana.

Wild Dog and Feral Pig Control

Council’s Pest and Stock Route Officer provided landholders with the loan of traps to control Wild Dogs in the Cobbs Hill and Brooklands area, Feral Cats in the Wooroolin, Nanango, Proston and Wilkesdale area and Wild Pigs in the Wooroolin area.

Landowners were supplied with 100 Doggone Baits in the Boondooma area, 400 Doggone Baits in the Tarong area, 20 Fresh Dog Meat Baits in the Tarong area and 12 Fresh Dog Meat Baits in the Gordonbrook area.

Rabbit Control

Council injected one rabbit with calici virus in the Coolabunia area.

Wandering Livestock

Council received 7 requests to attend to wandering livestock requests across the region resulting in the impoundment of one horse.

Stock Route Grazing Permits

NRM staff assessed no roadside agistment applications during April.

Saleyards

Saleyard staff inspected 1752 head and processed 2022 head through the dip in April. A total of 1109 head were sold through the Coolabunia Saleyards.

The first Weaner Sale for the year held at Coolabunia on Thursday 23 April 2020 attracted 833 head. A total of 829 head were sold liveweight with a further 4 being sold at Auction and no head being passed in. Total sale generated \$817,989.75.

Planning:

Planning during COVID-19

Amendments to Queensland's planning legislation are now in effect to address concerns raised by a range of stakeholders, including local government and industry, in response to the COVID-19.

Queensland's planning legislation has been amended to:

- *allow the Minister to decide when an essential business or use, for example supermarkets, should be able to operate and restock 24 hours per day, seven days a week, during an event such as the COVID-19 public health emergency, or other future disasters;*
- *provide the opportunity for any person to seek relief from existing development application conditions or other operating constraints through a simple application to the state for a temporary use licence made to the state*
- *introduce flexibility for the Minister to suspend or extend any of the statutory timeframes across the planning framework.*

The new provisions provide for business continuity and supply by removing planning constraints which could be limiting the operation and delivery of essential services.

These provisions are now a permanent part of our planning framework, providing flexibility to respond to not only COVID-19, but also to floods, bushfires, cyclones and other disasters. However, the effect of these powers is temporary and only applies for the duration of the declared event.

The Planning Minister declared the COVID-19 event as an applicable event under the amended legislation on 19 March 2020. The Minister made a blanket declaration allowing supermarkets, warehouses and transport stations that directly support the supply of food and essential services to operate 24-hour, seven days a week to ensure that they can work around the clock to deliver vital goods and services. This declaration is still in place supports the Roadmap to easing Queensland's restrictions.

Relief Building Certifier

Council invited quotations for a suitably qualified and insured Private Building Certifier to support Council's Building Certifier in delivering building certification services. The service may also include providing building certification services and advice to Council's Property Section on properties owned by Council.

The focus of this position is to support Council's building certification service by undertaking building certification for Class 1 and Class 10 buildings and structures and other building classes on occasion as determined by Council's Building Certifier, meeting statutory requirements and community expectations.

This position will be fixed for 12 months and allow Council's Building Certifier to complete outstanding certifications and inspections and allow for annual leave. In the longer term the position will allow Council's Building Certifier to undertake compliance work and support building activities of community and not-for-profit organisations that lease Council land.

Compliance:

Dog and Cat Desexing Initiative

The RSPCA's statewide annual desexing initiative known as "Operation Wanted", is running again this year and starts 1 June 2020 and concludes 31 August 2020.

Dog and Cat owners are able to access a 20% discount on normal desexing prices at participating vets during the campaign.

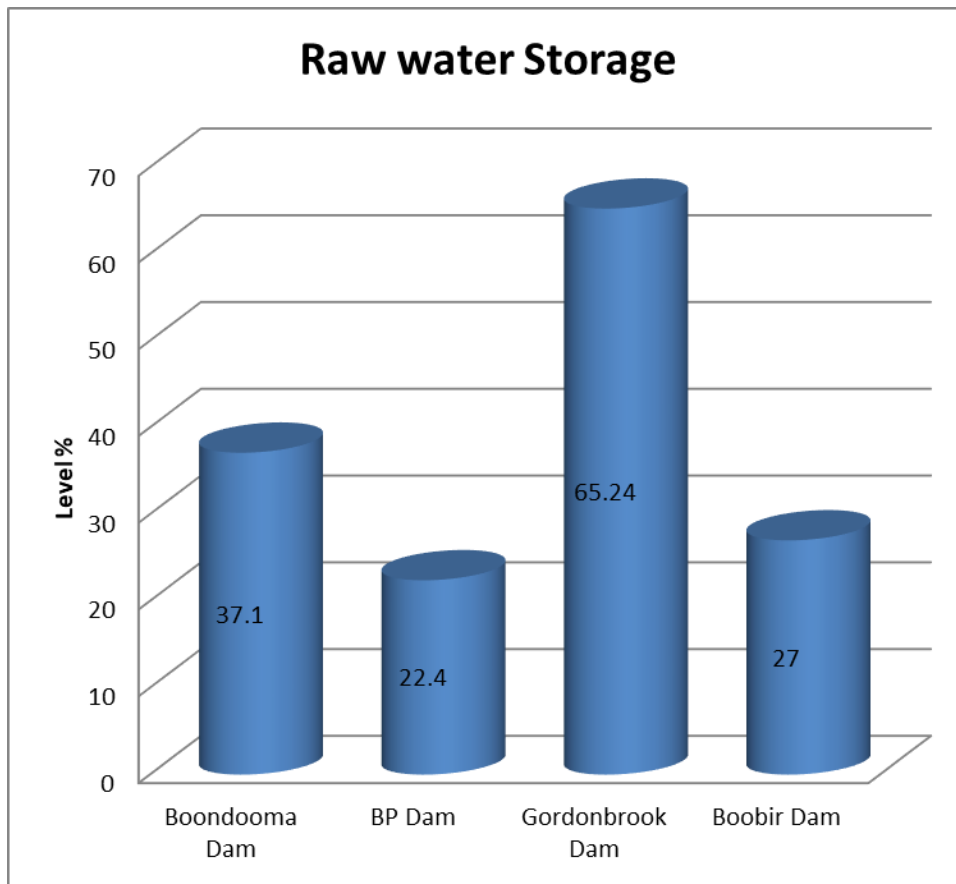

All towns remain on Level 3 restrictions.

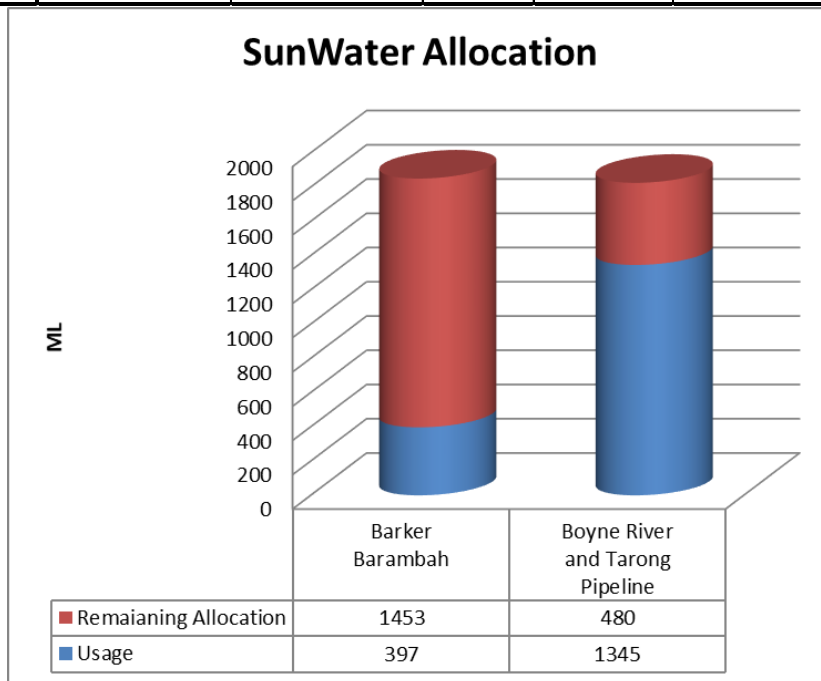

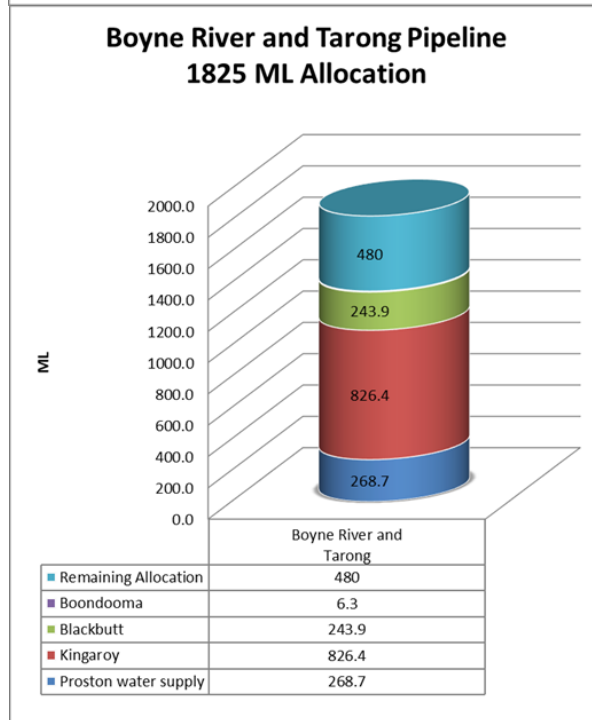
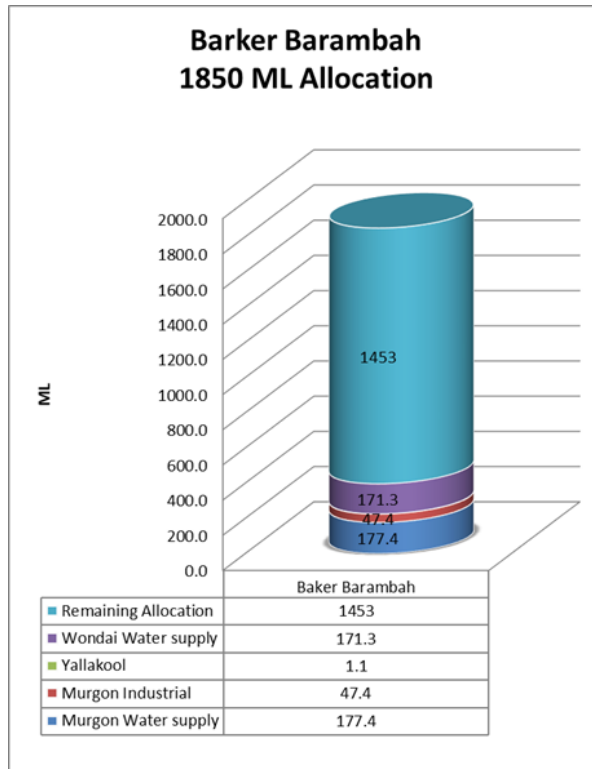

Waste:**COVID-19 Update**

Council's Waste Services wheelie bin collections and waste facility operations have continued relatively normally during this corona virus period.

With a number of people being restricted to home because of non-essential business closures there has been a noticeable spike in the volumes of waste being received at Council's various transfer stations. The Easter long weekend in particular saw considerable waste volumes received. Council waste staff and contractors have been able to deal with increase.

COVID-19 and the State Waste Levy

The State are considering whether to continue with the scheduled \$5 increase to the State Waste Levy, which was set to increase on 1 July 2020. There has been a number of entities lobbying the State government in this regard. No final decision has been released by the State concerning the State Waste Levy at the time of writing this update.

COVID-19 and LGAQ Waste Forums

LGAQ has been facilitating a number of online forums between local government waste managers and the State to make sure that all Councils are keeping up to date with the Health Directive requirements. South Burnett Regional Council's Waste section have been participating and reports that our responses to date have been in line with the Health Directive as well as other local government Council waste department responses to the COVID-19 phenomenon.

Asset Management

Council's Waste section has been very busy in 2020 finalising its Asset Register and developing an Asset Management Plan. The final draft Waste Asset Management Plan will be presented to Council shortly.

12. Portfolio – Rural Resilience, Parks & Gardens, Property & Facility Management, Indigenous Affairs

12.1 Rural Resilience, Parks & Gardens, Property & Facility Management and Indigenous Affairs Portfolio Report

Rural Resilience:

Planning is beginning in anticipation of funding being received as part of the Federal Government Drought Package. The drought is still having a large impact on our rural communities. I am very pleased to lead this new Rural Resilience Portfolio. I think that Council dedicating a portfolio to rural resilience shows that we value our rural communities and that we understand the struggles they face with changing weather patterns. I am excited to lead this portfolio and look forward to working more closely with our rural communities in this role.

Parks & Gardens:

Kingaroy, Murgon, Wondai, Proston, Nanango, Blackbutt and all surrounding areas

With the welcomed rain falling in the South Burnett parks over the previous months, staff have been kept extremely busy mowing green spaces across our region. 15 staff on mowers worked tirelessly during this period and at times staff thought, they were fighting a losing battle. Finally, with the slower growing conditions they gained the upper hand. The mowing schedule is now back on track and staff have been able to start working on completing finer touch ups. This includes weed eating, spraying of bindis, revitalising soil and timed irrigation in gardens with tree and hedge pruning starting throughout the CBD areas.

There are a number of trees in the QE11 Park in Lamb Street that are very old and are unhealthy. Council engaged Independent Arboriculture Services and they produced a report for each tree with recommended actions. Three Chinese Celtis trees have now been removed due to safety concerns

following the Arborists report. The stumps will be removed and another tree planted to replace and compliment the area.

Rogers Drive roundabout revitalisation program has begun with the first 45 established trees planted from Bunnings past Rogers Drive heading to Nanango. Work will continue over the coming weeks with most planting expecting to be finished by the end of May.

Slashing of the Rail Trail has been completed from Murgon to Kingaroy and now staff are starting to re-oil the chairs and 1km safety markers, and the ones completed are looking great. Surface maintenance has been undertaken along certain areas of the trail as per customer requests.

Parks staff have undertaken duties as requested in response to the Federal and State Government direction with COVID-19. As of last Saturday all playgrounds, skate parks and open park space have been re-opened however strict physical distancing measures still apply and gatherings will be limited to a maximum of 10 people. Council has updated signage in all these areas to ensure a consistent message is received within our community.

Council has introduced cleaning of all playground equipment etc to occur every Monday & Friday bringing them in line with what is being undertaken in our public amenities currently.

W4Q – *the installation of soft-fall in Memorial Park & Apex Park is completed.*

Capex – *The playground & soft fall renewal at First Settlers Park Benarkin & Les Muller Park Blackbutt are now completed. Apex Park has had a new footpath installed connecting the carpark to the existing ramp, new fencing and repair to lookout sub structure has also been completed. Pruning of trees to enhance the view from the lookout over Kingaroy is now completed.*

The cricket pitch at River Road has been replaced with a concrete slab and new synthetic grass laid. Kingaroy Junior Cricket club have complimented Council on how good it looks and can't wait to start playing on the new surface.

Both Nanango and Kingaroy Skate Parks have had additional ramps installed and were ready for use in time for the stage 1 easing of restrictions.

Dams

Both Boondooma & Bjelke-Petersen Dams closed on 27 March 2020 due to the COVID-19 requirements. Locked gates & signage were installed at both park entrances. All guests with bookings up to 31 August 2020 have been contacted and refunds/credits processed.

With the easing of restrictions from midnight 1 May 2020 both Boondooma & Bjelke-Petersen Dams were opened to the public within a 50km radius from 6am to 6pm daily, with one boat ramp and one amenity opened for use. These restrictions have remained in place with the only change being that travel within the region is up to 150km from a person's home, still maintaining social distancing and ensure gatherings are no greater than 10 persons. Accommodation and camping remains closed and is anticipated to reopen in line with Stage 2 easing of restrictions in June 2020 on a date to be confirmed.

Property and Facility Management:

Ringsfield House roof and structural tie down upgrade project has been awarded to Campbell Construction Company. This project has commenced with site preparation and security fencing being installed early this month. This project is partially funded by Department of Local Government, Racing and Multicultural Affairs – Grants and Subsidies Program and partially funded through Council's Capital Works Program.

Council has awarded contracts to Total Pool Renovations for the installation of new pool filtration system into Wondai Swimming Pool. Works will include craning in the tanks, circulation pumps and material to the site. Also contracts have been awarded to Zane Pool Heating for the installation of solar heating for Murgon and Wondai Swimming Pools. Works to commence during May.

During the closure of swimming pools under the COVID -19 restrictions Council has brought forward maintenance works at the South Burnett Aquatic Centre. Works have been scheduled over the next 5 weeks include the replacement of valves, replacement of grandstands, new floor coverings in the kitchen and replacement of rusted steel supports and the plastic grates around the hydro pool.

Council has completed the removal of above head fuel storage at Wondai Depot. Further works include the removal of two small buildings which will improve traffic management within the depot, disposal of non-used assets and addressing Workplace Health and Safety regulations.

Council awarded a contract to Paul Reeves for the renovation of 2 bathrooms in the Brighthaven Units and 2 bathrooms in the Drayton Units. Works have commenced and due to be completed by the end of June. Both sets of units have been fully tenanted during 2019/20, up until the works commenced.

Due to COVID-19 restrictions the Peanut Thrasher will now be restored and repainted by local contractor. This will ensure the thrasher restoration can be completed within timeframes and moved back to the Kingaroy VIC and Heritage Museum.

The Property section of Council is continuing to handle lease enquiries, surveying of lease areas and negotiations of lease conditions as an ongoing work in progress with community groups and commercial operators.

*The issue of vandalism, particularly in Kingaroy was higher this year than previous years and there are challenges that this behaviour brings to maintaining community assets. In the last seven months between 21 September 2019 and 11 May 2020 the cost to Council of vandalism has totalled **\$14,967.18**. Council would be grateful for help from any member of the public who witnesses an act of vandalism to please call Policelink on 131 444.*

Indigenous Affairs:

Parks and Gardens assisted with the tidy up of the checkpoint area at Cherbourg by whipper snipping the fence line both sides from Borchert's Road to 100 metres past the check point, as well as mowing the crib hut and car park areas.

The federally funded footpath project from Cherbourg to Murgon has been put on hold due to the COVID-19 restrictions. Council is working with Venus Rabbit who is a Wakka Wakka indigenous artist, to paint an owl and a serpent as part of the disk display on the new Murgon footpath.

On behalf of our Council team I would like to congratulate the new Mayor of Cherbourg, Mayor Elvie Sandow, and the new team on the Cherbourg Aboriginal Council. As the restrictions ease it will be good to again be able to meet with the newly formed South Burnett Aboriginal & Torres Strait Islander Group to further advance relationships across our whole region.

13. Portfolio – Economic Development – (Industry, Agriculture, Water Security, Tourism)

13.1 Economic Development Portfolio Report

Resolution:

Council's Economic Development team reports directly to the Chief Executive Officer and works across two brands, Business South Burnett and Discover South Burnett. These brands are currently used in all promotional activities including dedicated online and social media activities.

The core fundamentals of Council's economic development function are to:

- Develop and maintain effective relationships within the community, local business, industry organisations, government agencies and investors.*
- Enhance and support business investment, growth and retention within the region.*
- Implement Council's strategy and direction (yet to be reviewed by this Council).*

As part of the Corporate Planning process, over the coming six months it is recommended Council work toward re-defining the core role, responsibilities and expectations of Council's economic development function. This means Council will set a clear strategic plan for its role in economic development and tourism, including the future operation of Visitor Information Centres. This process will ensure all activities are aligned to the Council's desired outcomes, with a strong focus on meeting the region's needs, supporting its ongoing sustainability and looking to opportunities for future growth.

Draft 2025 South Burnett Economic Development Strategy

As part of the councillor's recent induction program, each councillor was provided with a copy of the draft 2025 South Burnett Economic Development Strategy for information purposes. Following post budget discussions, Council will prioritise finalising this strategy in preparation for planned public consultation prior to its adoption. This process will include setting clear expectations and accountabilities aligned to Council and the broader community's desired direction, as well as defining a suitable reporting structure in terms of suitable key performance indicators.

Council will work to review and workshop the Draft 2025 South Burnett Economic Development Strategy to set a clear strategic direction for its economic development and tourism functions as soon as reasonably practicable. These discussions are to include a review of the future operation of Visitor Information Centres.

COVID-19 Update & Economic Recovery

The evolving impacts of the COVID-19 pandemic represent the most significant challenge to Australia's economy since the Second World War. Across the South Burnett, business and industry continue to adapt and flex to what is considered the new normal, strengthened by the region's diverse and unique economy; that in some ways will continue to help cushion the blow.

Limited rainfall and the prolonged impacts of drought are continue to present ongoing challenges across the agricultural sector for graziers, producers and associated supply chains. Factors including fluctuating markets, concerns regarding water security, grain shortages, increased export or transport costs and alike, are just a few examples of the issues our region will continue to face.

Since early April Council's economic development team has helped to connect local business groups, chambers of commerce, state and regional agencies, to encourage the flow of information

and reduce the potential of miscommunication. This has included facilitating the weekly South Burnett Economic Action Plan meeting. All information shared at these meetings is communicated via the BEAP BEAP weekly e-newsletter that is distributed to Council's master business contact list and across the Localised network. Membership to the Localised network is free, with the aim of connecting all businesses across the Wide Bay Burnett, providing a place to advertise goods and services to the local business community and engage with other businesses.

The statistics below demonstrate the readership of the BEAP BEAP newsletter:

- 6,323 total opens and 693 total clicks
 - 3 April – 2,072 total opens and 208 total clicks
 - 9 April – 1,458 total opens and 88 total clicks
 - 17 April – 1,551 total opens and 351 total clicks
 - 24 April – 1,242 total opens and 46 total clicks
- Most popular clicks include JobKeeper, Takeaway South Burnett, Localised and Mental Health Management for business

The statistics below demonstrate the interactions across the Localised network (<https://widebayburnett.localised.com.au/southburnett/>):

18 new users and 6 new business profiles

- 3,297 page views
- Increased posting of events, articles and announcements
- Community submitted content has high engagement

These weekly meetings have informed the Local Disaster Management Group on a range of subjects including mental health for business, commercial and residential rent, JobKeeper, implementation of physical distancing in retail spaces, takeaway food options and business situation reports.

Economic development continues to actively engage in regional meetings and briefings regarding workforce requirements, tourism, hospitality, the pork industry, regional economic impact and recovery across the Wide Bay Burnett region.

Long term shovel ready projects in the pipeline

The economic development team has been working with a number of local private enterprises to scope a list of external shovel ready projects based in the South Burnett that total a value of \$42.8 million. If successful these projects would encourage significant future growth and an increase in jobs in the region. The team will continue to support these stakeholders by connecting them with the relevant support bodies and agencies, and advocating for funding within its networks and circles of influence.

Tourism

Council's role is to contribute to the growth of tourism through overseeing the operation of Visitor Information Centres, engaging with local tourism operators, regional and state bodies to inform tourism initiatives.

Due to the significant changes in tourism and travel as a result of the COVID-19 restrictions, Council decided at its April Council meeting to review the proposed 2020 Marketing Plan in collaboration with the South Burnett Tourism Advisory Committee.

At the South Burnett Tourism Advisory Committee meeting on 11 May 2020, the committee discussed a short term proposal to market the South Burnett to locals, in an effort to encourage our residents to explore local attractions and enjoy the many natural experiences on offer. Further work in shaping these marketing suggestions will be undertaken over the coming weeks, in a way that aligns with the government's road map for easing restrictions.

Planning for proposed marketing that concentrates on generating exposure in neighbouring regions as restrictions are relaxed and the travel radius is extended is currently underway.

In the meantime, economic development will continue to work closely with the South Burnett Tourism Advisory Committee and LTO Visit South Burnett to understand how it may be best positioned to collaborate in any potential destination marketing activities into the future.

A strategy to open the Visitor Information Centres is currently being considered with further information about the proposed dates to be provided at the next Council meeting.

Water Security Infrastructure Project – North and South Burnett Options Assessment

The Australian Government's National Water Infrastructure Development Fund (NWIFD) grant for the study of water supply requirements in the North and South Burnett regions is administered by the Department of Natural Resources Mines and Energy (DNRME).

To date, this study has examined the feasibility of a range of options that would increase water security for urban users, and enable the growth and expansion of industrial and agricultural activity, in ways that will create new jobs and support economic growth. While COVID-19 has changed the way in which community consultation was being conducted with key stakeholders recently, online meetings and telephone calls have been ongoing.

Currently the project has progressed to stage two, the option analysis stage (previously known as the Preliminary Business Case), and will identify the preferred options that best address the problems and deliver the required benefits through a robust process of review and analysis. The purpose of this stage is to reduce the longlist of options to a shortlist, which will be subject to further detailed, individual analysis.
