## 1. PRIMARY ROLE

This is a training position. The traineeship will cover a twelve (12) month period. Continued employment on completion will be subject to organisational needs and cannot be guaranteed.

Throughout the traineeship the trainee will be required to complete a Certificate II in Horticulture whilst gaining parks and gardens experience through day-to-day activities in Council's Operations.

## 2. KEY RESPONSIBILITIES

Key duties and responsibilities may include, but are not limited to:

1. Commitment to undertake all training requirements and successfully complete a Certificate II in Horticulture whilst gaining parks and gardens maintenance experience through day-to-day activities in Council's Operations
2. Assist under direction in the maintenance of the parks and gardens
3. Operation of small ride-on equipment and motorised hand equipment
4. Provide a high level of client service at all times, to both internal and external clients
5. Refer matters that impact on Council to appropriate Supervisors or Manager
6. Maintain a record of training such as a training record book
7. Complete additional activities and reasonable directions given by management

**3. ADDITIONAL FACTORS**

- Ability to undertake manual lifting
- Working outdoors in hot conditions

**4. ACADEMIC, TRADE QUALIFICATIONS AND OTHER LICENCES - MANDATORY**

- Successful completion of Year 10 School Certificate
- Minimum requirement of a current C Class driver's licence
- General Safety Induction for Construction Worker Certification (White Card) – (desirable)

**5. KEY SELECTION CRITERIA**

1. Commitment to learn new skills and to complete a formal qualification in Horticulture
2. Ability to work outdoors in a physical role undertaking manual tasks
3. Sound literacy and numeracy skills
4. Sound communication skills
5. Proven ability to follow direction and at times work with minimal supervision
6. Ability to work effectively in a team environment
