Summary of Works

The scope of works of this project is to utilise Council owned land located on George Street, adjacent to the old rail corridor for a formalised off-street carparking area. This will provide the community, businesses and tourists a safe and central location to park and access the Kingaroy CBD.

The scope of works is to provide an asphalt sealed parking area to a modern design standard including; associated kerb & channel and drainage, pavement, lighting, CCTV surveillance, concrete footpath, landscaping and other required safety features.

Concept Design

The George Street Carpark Project is designed to provide a centralised parking area for the Kingaroy CBD and the trail head for the Kilkivan to Kingaroy Rail Trail, while balancing the lost carparks from the Kingaroy Transformation Project due to compliance with engineering requirements in the design. This concept provides a minimum of 97 carpark and provide for a number of vehicle configurations and will allow for additional spaces as future stages are developed.

Benefits to CBD & Rail trail interconnection

This facility will provide a formalised and centralised parking area for the Kingaroy CBD in a location that promotes access to Haly Street, Glendon Street, King Street, and Kingaroy Street. This will help



bring visitors to surrounding retail and food businesses. The close vicinity to the final destination of the Kilkivan to Kingaroy Rail Trail will act as a convenient and safe trail head for all users.

The location in relation to the CBD will provide parking opportunities for retail workers in the area to alleviate the stress on availability of on street parking. The interconnection with King Street carpark will give east and west travel possibilities to the new one-way operation of George Street. This will ultimately lead to lower congestion at the George Street entry on Haly Street.

KINGAROY TRANSFORMATION PROJECT UPDATE

Construction Progress and Budget Update

The project continues to make reasonable progress with works continuing in Alford Street West and Alford Street / Kingaroy Street intersection, a slight delay has occurred in the construction program due to supply and wet weather delays of about seven (7) days.

The relatively soft start has been important for the delivery teams to trial and optimise construction methodologies and resolve construction issues and techniques. This will reap significant benefits moving forward and has avoided potential rework due to conflicting contractors and works. Significant learnings have been made and a first stage debrief is being programmed for late April.

This soft start has also allowed the delivery and safety teams to review construction and safety activities and adjust processes and plans accordingly to meet legislative and regulatory requirements. Additionally, it has allowed business access and footpath / road closure methodologies to be trialled and adjustment to occur in consultation with businesses.

Overall, the program is on track to deliver on or ahead of the current program of works, scheduled finish date.




Image of footpath north side of Alford Street showing temporary footpath for shop access

the above budget now includes DTMR corridor and allocation of \$1.5M. The total Council budget remains \$13.9M. The current Council EFC remains at around \$13.1 as no contingency has currently been accessed. When variations occur the EFC may increase with an associated contingency reduction.

The current progress and costs for Alford Street continue to indicate that the project to date is generally on track for overall timeframes and costs. It should be noted that it is still early in the project delivery phase so accurate trends across some items are still developing however the current as at 19th April 2021 projected estimated final cost (EFC) for Alford Street (Youngman – Glendon) is tracking at 98% of estimate. Forecasts and variations will be continue to be assessed as the project continues and cost data is received.

We have seen some individual items exceed original estimated unit rates including kerb and channel and stormwater. A review of each of these tasks has led to an adjustment in delivery methodology, materials and planning and which are being managed closely with construction teams. A number of other items are tracking below estimate and on balance Alford Street (Youngman – Glendon) is considered to be tracking close to estimate.

As procurement and construction activities progress a more accurate understanding of actual costs, unit rates and expenditure forecasts are being developed allowing better reporting in relation to cost and progress and allowing close management of items that exceed estimate. A number of elements have been reviewed and where necessary delivery options adjusted eg delivery of Raised Planters.

External Agency Update

With the DTMR contract and funding now confirmed a revised program and expenditure forecast will be prepared having regard for available construction resources and procurement requirements.

Council has not yet secured a commitment for external funding for underground power through discussions and negotiations with Energy Qld and the Australian Energy Regulator. The project will proceed with power remaining above ground and Council will continue to liaise with Ergon to consider including works in forward works programs as they are developed.

The project delivery team will continue to provision for future undergrounding of electricity as approved and is working closely with the local Ergon team to ensure adequate provisioning is installed during the construction phase to facilitate future undergrounding.

Project Risks and Variations

Material supply continues to be a challenge with lead times changing regularly. To date this has not created significant problems and is being managed by purchasing ahead of schedule and planning works to align with available resources.

The supply of some goods and materials continues to be a challenge with a number of items experiencing significant delays and cost increases including;

- Supply of reinforced concrete pipes 10% price increase and supply times > 20 weeks
- Supply of PVC conduit and pipes 16% price increase and supply times > 6 weeks
- Supply of lights and electrical controllers supply lead time 5 -6 months
- Supply of lights poles and traffic signal poles supply lead time 12- 14 weeks

There are continuing difficulties in procuring some resources with a number of invitations to quote receiving no or inadequate submissions or excessively high cost of submissions. The procurement team and project team have been actively consulting with local industry providers to assess capacity and constraints within the market. This creates a challenge to the project for local capacity to deliver the KTP and other Council projects and is being managed internally with other Project Managers.

A variation has arisen in relation to the upgrade and replacement of traffic signal loops and electrical pits associated with DTMR Traffic signals. Due to the existing electrical pits requiring level changes as a result of the KTP they must be upgraded to meet current DTMR standards, which require new pits to be installed by DTMR pre-qualified suppliers. The full cost of this variation is unknown at this stage but is estimated to be between \$10,000 and \$20,000 per intersection with Council maybe having to contribute to one of the intersections but this negotiated with TMR.

Advice from telecommunication service providers and technical experts is that additional spare conduits are required and should be installed now to cater for upgraded services in the future. Some limitations exist in relation to sharing of common infrastructure within communications networks. Additional conduits and larger pits to cater for future technology capacity in Alford Street have increased from 1 to 5. The progression of this item is being monitored closely to assess the impact however the cost to date is being absorbed within current allocations. An estimate of cost impacts across the entire project will be reviewed after the completion of the current stage of works.

Forward Program

Works are planned to continue in Alford Street (Haly – Glendon St) for the immediate future with the concentration being on Alford Street west of Glendon Street and Glendon Street Roundabout. Water main replacement works and stormwater installation are also being brought forward in Haly Street as early works to allow other elements to proceed once resources are sourced.

Additional contract resources (civil contracting, concreting and electrical installers) are being brought into the project to allow a more systematic delivery and speed up progress allowing crews to maintain continuity in delivery. Communications, Electrical, streetlighting and communications conduit

installation being a priority to allow progression of kerb and channel and stormwater upgrades and associated road works.

The three (3) week lookahead in attachment B provides an indication of planned activities and which is actively monitored to manage any emergent changes that arise.

Following a visit by the Division of Workplace Health and Safety inspector and review of traffic movement and safety measures, recommended changes to protect the workers from the risk of errant vehicles has required the closure of one traffic lane and adjacent parking. Whilst this has impacted traffic flow the offset has lead to a far safer and less congested site and generated productivity improvements through workers not being "on top" of each other.

Key planned construction activities

- Alford St concrete footpath commencement in week of 27 April
- Alford St north footpath completion week of 10 May
- Parking on Alford north is planned to be opened on 24th May at the latest
- Progressive Glendon St roundabout Closure 4th May onwards
- Haly St Water main and stormwater replacement 10th May onwards

Key Milestone Activity Dates:

- Kingaroy Street commencement currently planned for late June 2021
- Haly Street commencement currently planned for May 2021 (Water and Stormwater)
- Works in Alford Street and Glendon St Roundabout to be completed prior to Bacon Fest in August 2021

Forward programs are subject to amendments to adjust to funding and construction constraints with ability to fast track some works if required and by engaging additional resources.

George Street Carpark stripping of grass and surfaces with temporary gravel surfacing is planned for early to mid-May using recovered gravels from the project and Youngman Street resurfacing works. Consultation with any affected businesses will occur prior to commencement.

PRECIS

Clark and Swendson Development – South East Kingaroy Trunk Water Infrastructure

SUMMARY

A requirement for significant trunk water infrastructure in south-east Kingaroy has been previously identified and recently reinforced by studies undertaken on Council's Managing the Infrastructure Pipeline Program (MIPP). While the timing for multiple infrastructure components required will be dictated the relative priority of these and identified in the 10-year capital works program under development, key stakeholders have requested Council consider prioritising components of the works for early delivery in the program. The matter was present to the March General Meeting and left to lay on the table until a revised report could be brought back with costs and considerations of a fourth option.

OFFICER'S RECOMMENDATION

That the committee recommend to Council:

That Council:

- 1. Advise the developer that Council unable to advance funding to commence these works due to other network priorities; and
- 2. Advise the developer that they can build their own infrastructure to service their development only; and
- 3. Consider options for staged delivery of components of the planned trunk water infrastructure for Kingaroy, including Option four (4) of this report, in its Ten (10) Year Capital Works Program.

FINANCIAL AND RESOURCE IMPLICATIONS

Ten (10) year Capital Budget deliberations by Council are currently underway, if Council was to fund works to proceed with Trunk Infrastructure Upgrades then a funding model will need to be determined in adoption of Council's budget.

COMMUNICATION/CONSULTATION (INTERNAL/EXTERNAL)

Planning and preliminary design processes have commenced for the South-east Kingaroy Reservoir, Fisher Street pump station and associated mains. Planning underway builds on studies undertaken in the MIPP project and is based on the recommendations of that project. Engagement with potential impacted landholders and key stakeholders of the project has commenced.

Initial approaches to two (2) respective representatives have been well received with positive cooperation to date. Another representative made deputation to Council's February General Meeting in support of facilitating the delivery of the south-east Kingaroy water infrastructure. Subsequent

additional details provided by the same landholder were also considered in the preparation of this report.

ASSET MANAGEMENT IMPLICATIONS

Project planning for the South-east Kingaroy water infrastructure projects is supported by broader planning undertaken for the MIPP project which is nearing completion. In particular, the development of the forward capital works program includes projects prioritised by the numerous studies and the modelling to support finalisation of a ten (10) year capital works program is currently underway in preparation for consideration by Council. The MIPP project has included extensive components reviewing asset condition to inform renewal commitments anticipated in future years and will include full cost pricing and sustainability studies which are underway.

REPORT

A report to the General Meeting on 24 March 2021 was considered by Council and further information was requested relating to potential fourth option of capital upgrades to Kingaroy trunk water infrastructure in the vicinity of the Clark and Swendson Rd development. The matter was left lay on the table with the intention to bring back further information to the May Infrastructure Standing Committee under the following resolution:

Clark and Swendson Development – South-East Kingaroy Trunk Water Infrastructure

That Item 13.1 – Clark and Swendson Development – South-East Kingaroy Trunk Water Infrastructure lay on the table.

For completeness, the original report to Council's March General Meeting has been amended and reported in whole.

Numerous studies have identified the requirement for additional trunk infrastructure to support both existing and potential future development in Kingaroy. The MIPP project has significantly extended planning for water supply and sewer infrastructure in the South Burnett Region with significant focus on water supply network infrastructure in Kingaroy. In particular, one component of the MIPP project recently completed, *Network Modelling Planning Report – Water and Waterwater (Morris Water Pty Ltd 2020)*, reviewed network capacity in detail.

Recommendations of this report reinforced Council's strategy to meet recommended reservoir capacity in Kingaroy and included a reservoir site in south-east Kingaroy. The project recommended numerous prerequisite projects to augment capacity to the eastern side of the town where major industrial use and residential development have increased load on the existing water reticulation. Potential reservoir siting on elevated land to the east of Clark and Swendson Road was also supported as essential infrastructure with timing reliant on the delivery of enabling infrastructure including additional storage at Mt Wooroolin as well as boost pump upgrade and upgrade of sections of trunk main across the centre of Kingaroy.

Infrastructure recommended to support the South-east Kingaroy reservoir site includes:

- 3ML reservoir (A subsequent 3ML reservoir will also be required at the same site in the future to support increasing development in this part of Kingaroy);
- 75L/s pump station connected to the Haly street reticulation in the vicinity of Fisher street;
- DN300 mm rising main to the reservoir site;
- DN300/250 mm trunk reticulation main to Somerset street; and
- 100mm connection to the Kingaroy Heights pressure zone.

Council has commenced planning in advance of preliminary design of these components and this work includes early engagement with potential impacted stakeholders.

A presentation on this project was provided to the Water Infrastructure Standing Committee in February 2021 where the cost for all components to complete upgrades to the eastern side of Kingaroy was estimated at \$19.7M. Excluding the mandatory prerequisite works across the existing network, the estimated cost of the Fisher street pump station, rising main, reservoir and connection to Somerset street reported was \$8.3M. The presentation addressed representations from the proponent for an approved development on Lots 2 & 3 RP215835 ultimately served by the trunk works. Several options were presented for consideration to the February Infrastructure Standing Committee meeting:

- Option one (1): Developer installs their own supply infrastructure to service their development only with no cost to Council. A pipeline connection and temporary pump station at Valley Street were conditioned by the development approval in line with technical reports provided by the developer. The conditioned works are considered as a suitable option however the temporary pump station would become obsolete when trunk works are completed;
- 2. Option two (2): Council could work in collaboration with the developer to implement trunk upgrades excluding reservoir with an estimated cost \$5,417,492 working towards the ultimate solution of supply issues in this area; and
- 3. Option three (3) work in collaboration with the developer to implement trunk upgrades including reservoir with an estimated cost \$8,292,182 working towards the ultimate solution of supply issues in this area.

Both options two (2) and three (3) were identified with operational problems. In particular option two (2) presents issues with water age exceeding desirable limits resulting in loss of Chlorine residual and excessive THM levels which both prevent compliance with Australian Drinking Water Guidelines. Option three (3) requires significant prerequisite projects to be completed to allow the operation of the proposed Fisher street pump station.

The proponent for the approved development on Lots 2 & 3 on RP215835 has approached Council offering to assist Council facilitate construction of components of the proposed trunk infrastructure in conjunction with the approved development. A deputation to Council's February General Meeting was made by the developer in support of the proposal. In the deputation, matters raised include:

- the inclusion of trunk water infrastructure components supporting the development in the 2019 Local Government Infrastructure Plan;
- potential to access greenfield areas for the construction of trunk infrastructure;
- identified other stakeholders benefiting from early delivery of the proposed south-east Kingaroy reservoir and infrastructure; and
- potential solutions may exist to overcome water age issues likely in the staged trunk water system.

In subsequent correspondence to Councillors, the proponent for the development further proposed partial construction of the trunk rising main for the first 620m from Haly Street/Fisher Street intersection to the north-west corner of his development. Detailed consideration of this proposal confirmed:

• The 620m section of DN300 mm rising main construction proposed to service initial stages of the development on Lots 2 & 3 on RP215835 forms a small part of the ultimate proposed trunk works with no benefit to the operation of the overall network;

- A temporary pump station would be required on the trunk rising main to meet service pressure and fire-fighting requirements of the development and would be of similar performance to the conditioned temporary connection design via Valley Street. A Council provided temporary pump station would be similarly obsolete upon delivery of subsequent stages of the trunk infrastructure by Council; and
- The conditioned pipeline connection via Valley Street has future value and would be retained to benefit the reticulation in the developing area.

Further, without an additional significant gravity connection to another location in the network, an increase in water age of greater than 5 days would be anticipated even with all 29 connections complete in the first stage of development.

Thus the recent proposal has not overcome issues identified in the original report to Council in the March 2021 General Meeting.

As requested by Council at its meeting, analysis of alternative staging of the trunk infrastructure works has been undertaken to confirm technical viability and potential to benefit operation of Council's network including the approved development on Lots 2 & 3 RP215835. As foreshadowed in the previous report to Council, a fourth option could include the following components to be constructed in advance of the other major trunk infrastructure works while avoiding the need for any temporary pump station to service the development:

- temporary connection between Haly street and Somerset street mains via western sections
 of the proposed rising and gravity mains; and
- an additional connection to provide demand at the eastern end of the two (2) mains to reduce water age.

The components of staged ultimate trunk works proposed under this fourth option are:

4. Option four (4) work in collaboration with the developer to implement trunk upgrades including 1,050 m of DN300 (future rising main, Fisher Street to the South-west corner of development site) and 1,450 m of DN250/DN300 (future gravity main, Somerset Street to the South-east corner of development site) A temporary connection from rising main to gravity main would be required at the South-west corner of on Lot 3RP215835. The estimated cost of these interim works is \$ 2,263,392.


Under Option four (4), it is proposed to build the rising main and gravity main as shown in red on the attached Figure one (1). To facilitate water turn-over and reduce water age, the DN300 rising main and DN250/DN300 gravity main would be temporarily connected, creating a loop between Fisher Street and Somerset Street. The water main along the southern boundary of Lot 3 will be required with the final alignment to be determined to best suit the approved development layout.


Option four (4) requires that an additional permanent service connection to the Swickers facility be made to the eastern end of DN300/DN250 mm line (South-east corner of site) to provide water turnover and form the future gravity main from the South-east Kingaroy reservoir site. Option four (4) provides a gravity connection to the approved development site, via the future gravity main, which is capable of meeting minimum pressure and flow requirements, manages water age issues and broadly improves network operation by reducing the demand placed by the Swickers facility on a single offtake point in Haly Street. Option four (4) forms part of the ultimate planned trunk works for Kingaroy and includes no temporary components becoming obsolete upon delivery of subsequent staged components.


Possible forward capital works programs highlight extensive trunk upgrade requirements for Kingaroy. Options for staged delivery of the trunk infrastructure, including Option four (4) above, are recommended for consideration by Council in the development of the Ten (10) Year Capital Works Program.

Application to Supply Water Outside the Declared Water Area of the Proston Rural Scheme

Brief Report Water and Wastewater

Annual review of Council's Declared Supply Areas is planned to be presented for consideration at the June Infrastructure Standing Committee. Part of this work includes review of the Proston Rural Declared Area responding to Resolution 2021/53 of the Infrastructure Standing Committee held 3 March 2021.

Since the capacity of the Proston Rural Scheme to cater for increased demand is limited, analysis of ultimate infrastructure requirement to service all potential connections and assessment of available water allocation to cater for future demands within the current Declared Supply Area is required and underway. The potential for further increase to the demand on the Proston Rural Scheme is also being assessed as part of the analysis. Cost estimates for required capital works identified are accompanying this analysis and together are planned for presentation to the Infrastructure Standing Committee in June 2021.

These studies need to be completed in order that Council is appropriately briefed to consider the application to supply water outside the Declared Supply Area made under Item 7.3 to the March Infrastructure Standing Committee. It is recommended that Council's consideration of the Item planned for the May meeting the Infrastructure Standing Committee under Committee resolution 2021/54 is referred for tabling on the Agenda for the June meeting to coincide with completion of analysis and costing for the Proston Rural Scheme.
