6.1 NOTICE OF MOTION - SBRC TRANSPORT ASSET MAINTENANCE MANAGEMENT PLAN

File Number: 05-10-2022

I, Councillor Kathy Duff, give notice that at the Infrastructure Standing Committee Meeting of Council to be held on 5 October 2022, I intend to move the following motion:

MOTION

That the Committee recommends to Council that:

Council review and amend the SBRC Transport Asset Maintenance Management Plan to align the pothole repair intervention time frames with the Department of Main Roads Routine Maintenance Guidelines with a view to implementing the new intervention levels in January 2023.

RATIONALE

Transport and Main Roads Routine Maintenance Guidelines document provides technical guidance regarding intervention levels and target response times.

Category C Roads: - Bunya Hwy, D'Aguilar Hwy, Burnett Hwy, Kingaroy Barkers Ck Rd, Murgon Gayndah Rd, Nanango Tarong Rd, Kingaroy Burrandowan Rd Section *(Ch 0 to Ch 6.96)*, Chinchilla Wondai Rd Section *(Ch 132.64 to Ch 151.7)* and Kingaroy Cooyar Rd

- Lower Intervention Level: Diameter of 100mm or Depth of 30mm.
- Upper Intervention Level: Diameter of 500mm or Depth of 50mm a response time: 2 weeks after pothole recorded.

Category D Roads: - Chinchilla Wondai Rd Section (*Ch 71.62 to Ch 132.640*), Kingaroy Burrandowan Rd Section (*Ch 6.96- Ch 64.39*), Mundubbera Durong Rd, Wondai Proston Rd, Bunya Mountains Rd, Memerambi Gordonbrook Rd, Proston Boondooma Rd and Byee Rd

- Lower Intervention Level: Diameter of 100mm or Depth of 30mm.
- Upper Intervention Level: Diameter of 500mm or Depth of 60mm a response time: 3 weeks after pothole recorded

Category E Roads: - Kilcoy Murgon Rd, Maidenwell Bunya Mountains Rd and Okeden Rd

- Lower Intervention Level: Width of 100mm or Depth of 30mm.
- Upper Intervention Level: Width of 600mm or Depth of 80mm a response time: 4 weeks after pothole recorded.

Local Roads:

SBRC's Transport Asset Maintenance Management Plan (TAMMP) provides technical guidance regarding intervention levels and target response times.

Speed zone greater than 60km/hr:

- Lower Intervention: Diameter of 100mm to 200mm and Depth less than 50mm a response time: 540 days after pothole recorded
- Upper Intervention Level: Diameter greater than 200mm and/or depth greater than 50mm à Response time: 90 days after pothole recorded

Speed zone 60km/hr or less:

- Lower Intervention: Diameter of 100mm to 200mm and Depth less than 50mm a response time: 540 days after pothole recorded
- Upper Intervention Level: Diameter greater than 200mm and/or depth greater than 50mm à Response time: 180 days after pothole recorded

Emergency Works:

Our Transport Asset Maintenance Plan (TAMMP) has provision to suspend the plan in the events of disaster. Currently we are in an Emergency Works phase for severe weather events and potholes are forming part of the Emergency Works Programme to be completed by the 27 October.

Defects at lower/ initial Intervention level:

Defects are logged once they reach initial intervention level and are expected to be rectified before they reach upper intervention level. However, the response time starts from the day the defect is identified to reach upper intervention level. With pothole defects, all the recorded potholes including those at initial intervention level get attended to during the pothole run for the road.

CORPORATE PLAN

IN1 Continue to provide sound asset management strategies to maintain and improve Council;s road network, bridges, drainage and street lighting.

I, Councillor Kirstie Schumacher, give notice that at the next Infrastructure Standing Committee Meeting to be held on 5 October 2022, I intend to move the following motion:

MOTION

That a report be prepared and brought back to a February Executive & Finance Standing Committee Meeting detailing:

- The financial contribution and percentage of total general revenue Council received from every town and village in the South Burnett since 2013/2014 to what has been budgeted for in 22/23 along with the number of constituents in each division.
- The financial spend and percentage of Council's capital budget (including grant funds) spent across all asset classes and departments in each division since 2013/2014 to what has been budgeted for 22/23.

RATIONALE

Prior to running for council, I sought information about what had been invested in infrastructure across each division and the amount of general revenue received from each division and received the attached reports. I am concerned about the reputation of our Council, due to some of the online commentary that implies Council funds have been solely invested in Kingaroy to the disadvantage of neighbouring towns and villages. In the spirit of transparency, the purpose of this report is to help communicate to our region how funds and state and federal funding sources such as Works for Queensland, LRCI and Safe ST have been reinvested in our region historically and to present date.

As per the Councillor code of conduct for Councillors in Queensland, we must:

- Treat people in a reasonable, just, respectful, and non-discriminatory way specifically
- Treat fellow councillors, council employees and members of the public with courtesy, honesty and fairness.
- Ensure conduct does no reflect adversely on the reputation of Council.
- At all times, strive to maintain and strengthen the public's trust and confidence in the integrity of Council and avoid any action which may diminish its standing, authority or dignity.

As per Section 25 Human Rights Act 2019 (Qld) A person has a right to: -

b) not to have the person's reputation unlawfully attacked.

As a fellow Councillor, I have witnessed online statements that have caused me reputational damage and implied that I have neglected my responsibilities under the Local Government Act, to faithfully and impartially to carry out the functions, powers, authorities and discretions vested in me by local government act to the best of my ability and judgement.

The purpose of this report is to demonstrate to all constituents how funding has been collected and invested across the region over a period of time. While considerable funding has been invested in Kingaroy during this term, I understand the Kingaroy area had received smaller amounts of direct funding in the past, to enable the Council to save for the eventual replacement of failing under and above ground infrastructure in Kingaroy's CBD. I would like to be able to report the facts of previous

and current capital project spends to our community in an effort to create greater understanding of the challenges Council faces in balancing the competing priorities and the investments made. I also see this report, as a mid-term summary of the projects and activities that this Council has invested into date and the outcomes achieved. I have requested data across all asset classes, because I recognise there has been a considerable spend in all types of infrastructure and liveability projects and would like to see a report that also details our business units, including water, wastewater and waste.

Gravel/ Shoulder Resheeting

As a major portion of this year's gravel resheeting and shoulder resheeting program has been impacted by flood damage, the resheeting works are anticipated to be completed in conjunction with the flood damage program. 

Recent storm damage and flood response

Council crews continue to respond to Emergency Works under the jointly funded Commonwealth – State Disaster Recovery Funding Arrangements (DRFA) relating to the South Queensland East Coast Low, July 2022 Event. Council is continuing its discussions with the Queensland Reconstruction Authority (QRA) with a focus on reducing the impact on Council's budget with five activations currently requiring five Trigger Point payments of \$212,168.

So far, more than 957 July related Emergency Works sites have been completed out of 1650 identified. In some instances, these sites have been repaired multiple times, following previous events. Since the first severe weather event in November 2021, more than 6934 sites have been identified, 5463 have been repaired under Emergency Works.

Emergency Works under the July event are to be completed by 27 October 2022.

Two sub-contractor crews are currently engaged to clear blocked road culverts as part of the Emergency and Immediate Reconstruction Works response, these works were scheduled for completion on 9 August 2022. Due to the South Queensland East Coast Low, July 2022 related event, these activities have now been extended until 27 October 2022. Along with identified priority roads, zones 1,2 and 3 are considered to be complete. The crews are now working through identified locations in zones 4,5 and 6. Identification of affected areas continues in the remaining zones.



The damage assessment phase to allow the long-term Restoration of Essential Public Assets (REPA) continues, via RACAS, Asset Edge Recover data and site verification visits. These assessments include those works completed to date to identify any new July event related damage. Also many assessments that were complete prior to the July event were re-assessed for any new damage.

An external Contract for Submission 1 to complete 16 roads was awarded to Yesberg Earthmoving and commenced in Early May. These works are now complete.

A second submission containing 35 roads was recently submitted and approved by QRA. An invitation to offer was released to the market for 31 roads, with council to deliver the works on four of those roads. The works began in July and are scheduled for completion by the end of September, see overview of progress to date below in Table 1.

A third submission of priority reconstruction works on 64 roads in SBRC Zones 2 & 3, with a value of \$2.1Million is in the final stages of assessment by QRA. An Invitation to Offer has been developed for these works and will be released to market. Once approval to proceed has been received.

To date approximately \$6.2 Million has been spent across the five Events. The QRA has provided grant advances and a 30% payment on two REPA submission plus progress payments for emergency and immediate reconstruction works, total funding received to date is approximately \$6.5 Million. Further REPA submissions, Emergency Works and Immediate Reconstruction Works claims are currently being prepared in readiness for submission to QRA for approval.

The current SBRC Works capital program and some of the operational programs such as patrol grading are being impacted by emergency and immediate reconstruction requirements.

The Redfrost Team are currently prioritising the REPA inspection program to align with those assets identified in the SBRC 2022/23 CAPEX pavement reseal, rehabilitation and gravel re-sheet programs. The intent is to reduce duplication of inspection effort and to align these activities with a delivery strategy that addresses both CAPEX and REPA requirements within the required timeframes.

Council continues to identify major pavement repairs, predominately dig out and repair works. Works are completed at Albert Street, Arthur Street, Trussell & William Streets in Kingaroy. Works are due to finalise at the intersection of Gallagher Street and the Bunya Highway in Wondai before moving to King Street & Industrial Avenue, Kingaroy. Council crews are finalising works on River Road that includes both REPA and immediate reconstruction activities. Significant construction issues are being encountered with constant groundwater flowing in kerbs and within pavement subgrades. Investigations have commenced into the broader ground water issues within this area.

The major pavement repair scope of work is still evolving as council and contract personnel continue to inspect roads and identify damage in and around the SBRC region. There are currently over 250 individual repair sites identified within the Kingaroy area. Refer table 2 SBRC Major Pavement Repair overview below.

Investigations have commenced to identify appropriate pavement rehabilitation methodologies due to extensive lengths of pavement damage being identified. Examples include Burnett Street, Kingaroy and King Road, Maidenwell.



In September additional works were undertaken by the Dig Out Team at Gallagher Street, Wondai, photos below.

Blackbutt CBD Streetscape and Footpath Upgrade – Update 21 September 2022

Works along Roy Emerson Way (Coulson Street) are essentially complete. New bin surrounds and seats are due to be installed in October.

Works in Les Muller Park are also practically complete. Scope completed includes new concrete footpaths, new shelters and picnic settings, new soft fall and fencing to the playground as well as new garden areas and trees. Footpath surfacing and minor alterations to the Ken Allery Shelter are planned to be completed during October.

New Footpath upgrade works in Hart Street, linking the Blackbutt CBD to the Rail Trail have been completed except for the decorative surfacing which is proposed to be completed in October.

Repainting the town clock is planned to occur in October and the installation of a new clock movement mechanism is due to be completed before the end of December.



KINGAROY TRANSFORMATION PROJECT UPDATE

Construction Progress and Budget Update

The Glendon Street Community area was largely completed in mid-August after teams worked round the clock to ensure the project met the timeframes after the site was again impacted by extensive wet weather, including another activated rain event in late July. The wet weather caused extensive construction problems, delays and re-work on the site due to saturation and water inundation. This is now the 5th wet weather event during project construction.

The final asphalt works were undertaken in the second week in August with Fulton Hogan agreeing to make their team available to assist SBRC with additional maintenance repairs on Haly Street and Alford Street East.

The area was used for the first time during Baconfest and feedback on the area was positive particularly with the design for accessibility. The structures for this area are currently being finalised by BZE Murgon and are a due to arrive imminently for installation.

Final fit out works are currently well underway with final surfacing, structure installations and electrical systems. Street furniture and bins have commenced reinstalment and will progress with the surfacing. The project has suffered some further delays to supply chain issues and programming due to wet weather impacts particularly on surfacing. In discussions with the Australian Government the project will be given extensions of time to complete as necessary.



SUMMARY

The new alfresco structures within the Kingaroy CBD are reaching completion and Council should commence now regarding options for their activation and occupancy.

OFFICER'S RECOMMENDATION

That the Committee recommend to the Council that:

- 1. Council delegate to the Chief Executive Officer to negotiate agreements with the proponents of the Club Hotel Kingaroy and the Commercial Hotel Kingaroy for the occupancy of the adjacent alfresco structures with a fee of \$500 per annum, and;
- 2. Council call for expressions of interests from adjacent hospitality businesses for the occupancy of the four (4) alfresco structures in Kingaroy Street for a period of two (2) years or otherwise nominated with an annual fee of \$500 per annum to be implemented upon uptake of the second year option.

FINANCIAL AND RESOURCE IMPLICATIONS

Council should collect a nominal fee of \$500 per annum for the occupancy of the structures to contribute to the annual maintenance in particular the fencing. The timing of the charge would be subject to legal advice regarding fees and charges or whether the charge is taken as a contract.

The KTP team has received ongoing enquiries from businesses in particular licenced premises to progress the occupancy of the new alfresco structures in the Kingaroy CBD.

ASSET MANAGEMENT IMPLICATIONS

It is expected that the fencing will require annual maintenance in the form of oiling, the nominal fee is expected to cover initial costs for the upkeep of the area over and above normal operational maintenance for the area.

REPORT

Council is currently finalising the installation of the alfresco structures within the Kingaroy CBD. Officers have begun to field multiple enquiries of interest from businesses seeking occupy these areas. The areas have been installed principally to increase both day time and night time activation of hospitality within the CBD area and associated benefits to other businesses within the vicinity.

There are currently two (2) structures adjacent to the Club Hotel Kingaroy and the Commercial Hotel Kingaroy. It is proposed that these structure be utilised by these licenced premises with a suitable agreement delegated to the Chief Executive Officer to finalise. Conditions of these areas will be finalised, but key elements will include:

- Areas are occupied by the licencee and inclusive access must be maintained;
- Areas are to be used in a manner that actively increases activation and patronage of the CBD to the satisfaction of Council;
- Areas are strictly non-smoking and are not to be used as a designated smoking area;
- Areas including gardens must be cleaned regularly to Council's satisfaction;
- The costs of any damages caused by the operation of the area is to be borne by the proponent; and
- Agreements are for two (2) years with a \$500 per annum fee applicable from commencement or as otherwise agreed.

There are four (4) structures available for use in Kingaroy Street adjacent to the mid-block pedestrian crossing. It is recommended that Council seek 'expressions of interests' (EOI) from hospitality businesses in Kingaroy Street for their occupancy. The submissions will be reviewed by Council and businesses at should nominate how they intend to use the space to support activation of the street with hospitality for day and/or night time activities. The EOI would include in principle conditions similar to above. It is suggested that the agreement be also for a period of two (2) years (with second year optional) with a fee \$500 per annum to be payable from uptake of the second-year option, unless otherwise nominated or agreed.

PRECIS

2026/2027 Regional Roads and Transport Group (RRTG) Funding Nominations

SUMMARY

Council is seeking to submit applications for funding under the State Government Transport Infrastructure Development Scheme (TIDS) for widening of Kingaroy Barkers Creek Road, Booie, Kumbia Road, Kumbia and Memerambi Barkers Creek Road, Wattlecamp. These projects will include pavement construction and drainage upgrades to cater for the service levels of these roads. These nominations have been identified due to these projects having increased maintenance costs, driver safety and approaching the assets end of useful life.

OFFICER'S RECOMMENDATION

That the committee note the nominations of Kingaroy Barkers Creek Road, Kumbia Road and Memerambi Barkers Creek Road for 2026/27 TIDS funding as part of the future capital works program.

BACKGROUND

Council Officers are required to submit projects for additional funding approval for the 2026/27 TIDS Regional Roads & Transport Group (RRTG) program with Kingaroy Barkers Creek Road, Kumbia Road and Memerambi Barkers Creek Road being identified for upcoming rehabilitation works. Each of these nominations meets predetermined criteria of being Local Roads of Regional Significance (LRRS) and perform critical functions on our local road network. Should these applications be successful, then they could require a co-contribution of up to 50% from the State Government under the TIDS policy, however the Kingaroy Barkers Creek Road nomination would be 100% funded under this scheme.

Kingaroy Barkers Creek Road (TMR), Booie

There are three (3) sections of single lane seal on Kingaroy Barkers Creek Road between Wattlecamp Road and the Burnett Highway. This project nomination is between Ch 17.045 – 17.949 just to the east of the Wattlecamp Road intersection. The proposed widening would improve visibility, increase safety and significantly decrease maintenance costs on this road. The scope of work includes seal widening, associated formation widening, drainage works and tree clearing.

Stuart Street/ Kumbia Road, Kumbia

Stuart Street is a highly trafficked priority road within SBRC's road network, providing access to agricultural farms, orchards and emergency service bases within the area. Presently, it is a single lane (3.5m) segment of road for 320 metres on the southern approach into the Kumbia township along Kumbia Road from Ellesmere. Adjoining segments have been widened in previous years of LRRS Funding. The project scope includes road widening from 3.5m to 7m, with appropriate intersection shoulder and drainage treatments.

Memerambi Barkers Creek Road, Wattlecamp

Currently, Memerambi Barkers Creek Road has an unsealed, 7m gravelled formation and this project will include constructing and sealing for 1.53 kilometres (Ch 2.57 - 4.1) between Corndale Road and Pakaderinga Feedlot. The adjacent segments have been constructed under previous years of LRRS funding.

This road profile will reduce maintenance, improve safety, accessibility and increase transport efficiency to assist with B-double access to agricultural economic drivers in the area, which are currently accessed under permit requiring a pilot vehicle to ensure the safety of road users.

Memerambi Barkers Creek Road is the highest ranked unfunded project under the Project Prioritisation Tool that suits the criteria of this scheme.




Figure 1 - Kumbia Road - Cyan potential 25/26, purple proposed future year





Figure 2 - Memerambi Bakers Creek Road - Cyan potential 25/26, purple proposed future year

PRECIS

School Transport Infrastructure Program

SUMMARY

The State Government's School Transport Infrastructure Program (STIP) provides funding to improve the safety and operation of schools through new or improved infrastructure at the school and/or on the surrounding road network.

OFFICER'S RECOMMENDATION

That the Committee recommends to Council;

That the following funding applications be submitted for the following sites near schools;

- 1. Murgon School Crossing Upgrades;
- 2. St Mary's Catholic College Footpath;
- 3. Murgon State High School Parking Upgrades;
- 4. Murgon State High School Footpath;
- 5. Markwell Street Bus Interchange, Kingaroy; and
- 6. William/Toomey/Avoca Street Intersection & Parking Upgrades.

FINANCIAL AND RESOURCE IMPLICATIONS

The maximum amount of state funding available for a project is \$500,000 except in special circumstances. It is anticipated that most projects will be funded at a 50:50 subsidy basis (for example co-funding between TMR and Local Government).

Consultation has been held with some of the respective schools regarding STIP project ideas for endorsement prior to submission. Council officers have also been liaising with TMR Road Safety on preferred sites and have their support for these nominations. Officers will approach the remaining schools for comment on the proposals prior to submission in late October.

ASSET MANAGEMENT IMPLICATIONS

Council is obliged to manage its assets in accordance with the requirements of the Local Government Act 2009 and the Civil Liability Act 2002.

REPORT

Council is seeking to submit applications for funding under the next round of School Transport Infrastructure Program (STIP). Each of the presented nominations meets the STIP funding criteria regarding eligible school categories and typical works. Should these applications be successful, they will require a co-contribution of 50% from Council. The available funding for STIP projects is \$10 million dollars per year, from 2022/23 – 2026/27, with the current round being the first offered for application.

Council officers have identified the following projects for submission for STIP assessment in attachment one (1):

Murgon Crossing Upgrades

Murgon State School (MSS) and St Joseph's School service the Murgon and surrounding region with co-educational P-6 schooling levels. MSS's main entrance is located on Gore Street, with pedestrian crossing access to the Murgon Childcare and Learning Centre across the road. St Joseph's is near MSS, with its main entrance located on Angel Avenue with pedestrian crossing access. Both schools have access to a 25 bay carpark and turnaround, located off Angel Avenue servicing staff and visitors.

Both pedestrian crossings located on Gore Street and Angel Avenue function as a combined school and pedestrian crossing, however the existing crossing environments are non-compliant with the current MUTCD (Queensland Manual of Uniform Traffic Control Devices) standards. To upgrade these crossings to current standards, both crossings require updated line marking, signage and barber poles, with Angel Avenue also requiring the installation of blister islands to reduce the crossing distance of the road width.

St Mary's Catholic College Footpath

St Mary's Catholic College was previously awarded STIP funding for the 2021/22 financial year. Due to outside factors influencing the construction industry, the costs associated to complete the project as originally scoped exceed the available funding that was provided by the program. This required a reduction of scope to meet budget allocation for construction in the 2021/22 funding year, with the footpath from Albert to Fitzroy Street to be constructed when future funding became available.

Murgon State High School Parking Upgrades

With an increase in student enrolments, new school buildings and changes to the schooling system, Murgon SHS and surrounding residents are experiencing many issues with vehicle traffic, parking and congestion around school hours. In previous years a limited number of senior high school students were licensed and able to drive to school with parking availability being sufficient. However, with increases to the number of licensed school students enrolled at MSHS, it has highlighted significant parking deficiencies for the student community and residents in the surrounding neighbourhood. It is proposed to widen the road and install kerb and channel along the school frontage from Harm to Cooper Street, to assist with formalising orderly car parking within the road environment.

Murgon State High School Footpath

The footpath on Dutton Street East, from Murgon Swimming Pool entrance to Krebs Street intersection, has been identified as a condition state 10 footpath during forward works investigations

for pathways. With severe longitudinal cracks and vegetation issues, the footpath asset has reached end of life and is deemed a failed asset that is no longer serviceable. This project has been scoped to replace the failed bitumen footpath asset with a 1.5 metre wide concrete footpath to assist with catering for increases to the number of licensed school students enrolled at MSHS.

Markwell Street Bus Interchange, Kingaroy

The Markwell/William Street Bus Turnaround and Parking project was raised due to concerns regarding the safety of motorists, pedestrians and school children, who use this facility. There are observed deficiencies at this facility regarding the intersection alignment, geometry, pedestrian provisions, accesses, signs, line marking and delineation. The risk of these deficiencies can be lowered with the extension of concrete buildouts in bus set down locations and the renewal of faded line markings and signage.

William/Toomey/Avoca Street Intersection & Parking Upgrades

The William/Toomey/Avoca Street project was previously awarded STIP funding for the 2021/22 financial year. Due to outside factors influencing the construction industry, the costs associated to complete the project as originally scoped exceeded the available funding that was provided by the program. During assessment of the project scope against the allocated budget, the Markwell/William Street intersection was identified as the priority intersection for construction, with works on Avoca and William/Toomey Street intersections, were to be completed when future funding became available.

Works to be completed in Avoca Street consist of new line marking, pavement, kerb and channel, removal of an existing tree located at the end of the cul-de-sac, improve drainage and continue to support parking and existing bus movements. Intersection works at William/Toomey Street include setting the crossings back from the intersections and allowing for vehicle storage with extended hold lines and further protection of pedestrians with the installation of pedestrian refuge islands, bollards in the centre of the relocated crossings and the extension of chevron marked blister islands.

7.6 MCCAULEY WEIR ROAD ACCESS

PRECIS

McCauley Weir Road Access

SUMMARY

Numerous requests to open the locked gate on McCauley Weir Road and to allow access to the weir and adjoining reserve have been received by Council over many years. In 2012, Council revisited the history of access to the area and resolved the road and access to McCauley Weir remain closed. The McCauley Weir is a water impoundment owned by Council and the road accesses numerous private properties. At one time the weir was used as a recreation area by the general public.

This report provides a briefing on the history of the facility and recommends continued closure of the road to general public access.

OFFICER'S RECOMMENDATION

That the committee recommends to Council that:

- 1. Council maintains the locked gate on McCauley Weir Road to restrict general public access, with the exception of Council operational staff and landholders, to McCauley Weir Road beyond that location due to significant safety concerns; and
- 2. Continues to exclude recreational use of McCauley Weir and Reserve.

FINANCIAL AND RESOURCE IMPLICATIONS

Road and Recreational area

Consideration of the restriction of access to McCauley Weir and McCauley Weir Road were formally considered by Council at its General Meeting back in March 2012. Preliminary estimates were presented as part of that report. Significant safety issues exist within the approximate four (4) km section of unmaintained road reserve and extensive capital works would be required to address safety considerations regardless of level of service provided.

Additionally, as identified in the 2012 report to Council, if the McCauley Weir Road is opened to traffic, basic recreational facilities will be required at the weir site. Annual operational and maintenance costs will depend on the standard of road and facilities provided, usage and weather conditions experienced.

Water Infrastructure

Existing water supply infrastructure including the weir, pump station and rising main is not in current use though Council maintains an allocation from the weir on Cooyar Creek. There is no current plan to use McCauley Weir to augment raw water supply to Nanango.

LINK TO CORPORATE/OPERATIONAL PLAN

PROVIDING KEY INFRASTRUCTURE FOR OUR TOWNS AND VILLAGES – Develop, renew and maintain community infrastructure through sound asset management principles.

COMMUNICATION/CONSULTATION (INTERNAL/EXTERNAL)

Adhoc stakeholder communication was undertaken around the date of the previous report to Council in 2012. Council has been approached numerous of times regarding public access to McCauley Weir and McCauley Weir Road since that time.

Consultation with all impacted landholders is highly recommended prior to any change to access to McCauley Weir and McCauley Weir Road due to strong opposition to the proposal to open the section of the road beyond the locked gate to the general public expressed by impacted landholders.

LEGAL IMPLICATIONS (STATUTORY BASIS, LEGAL RISKS)

In the 2012 report to Council, results of an assessment undertaken for the current road reserve based on access for the general public use showed "extreme" risk. Significant capital work would be required to reduce risk mainly due to the local terrain and geometry of the road.

Further, since the date of the previous Council resolution, the onus placed on Council's to manage risk in recreational areas has significantly increased. Extensive planning considering recreational use and management of the impoundment would be required in order to manage new risks associated with access of the public to Council's reserve and impoundment at the McCauley Weir.

POLICY/LOCAL LAW DELEGATION IMPLICATIONS

Appropriate Council Policy to manage the use of the area would be required if a decision was made to open the area to public access.

ASSET MANAGEMENT IMPLICATIONS

Council does not maintain the section of McCauley Weir Road which is used as access by three (3) landholders. Opening of the road to the general public would require Council to annually provide for maintenance of the new road and recreational facilities.

REPORT

Requests have been received by Council staff and Councillors for many years requesting removal of the locked gate on McCauley Weir Road which has been in place for several decades. Commonly the purpose of these requests sought is to allow the general public to access the weir and surrounding area for fishing and recreational use. During the preparation of this report, it was evident that consideration of the matter by Council occurred as early as 2005 with a detailed review of issues and resolution of Council in 2012. Much of the background information within this report has been drawn from the report to the March 2012 General Meeting of Council.

McCauley Weir

The McCauley Weir was constructed in 1953 by the then Department of Local Government (Water Supply and Sewerage Section) for the Nanango Shire Council and was the town water supply for Nanango until 1996 when the new Barkers Creek bores came on line to supply the town.

The weir has a design volume of 290ML and allocation of 350ML and was last actively used in 1996 according to previous reports.

While the weir could provide a partial backup raw water supply for Nanango, the pump stations and rising main were identified as in poor condition at time of decommissioning. Last year the source was reconsidered but not considered to be a viable supplementary source for Nanango in the Total Asset Management Strategy (2021) developed under the Managing the Infrastructure Pipeline funded project. Regardless the weir, impoundment and surrounding 25 hectare reserve remain the responsibility of Council.

McCauley Weir Reserve

The area surrounding the weir and impoundment is a Reserve for Water Supply under the Trusteeship of the South Burnett Regional Council.

The area to the west of the impoundment was at one time used for recreational purposes and a toilet building was maintained to support the use. At the time the weir was used for recreational fishing.

The March 2012 report stated that the use of the area ceased soon after the Tarong Power Station constructed the "Tarong beach" at its cooling water dam. Access to the cooling water dam was later closed due to Power Station security concerns over general public use. Subsequently Council received requests to reopen the McCauley Weir reserve for recreational uses however Council records indicate numerous requests were refused. The 2012 report identified significant capital works were required to address safety concerns and to support recreational use of the reserve and suggested discussions with Stanwell around the reopening of public access to the Tarong Dam facilities given the previous high level of public use of that alternate facility.

McCauley Weir Road

Access to the weir and reserve is gained via McCauley Weir Road. The road is not maintained beyond the locked gate situated across the road at the junction between Lot 1 RP838599 and Lot 3 RP838600. Beyond this gate, the road becomes a narrow and winding track down a spur of the range west of the weir. It also provides access to two (2) residences. Evidence suggests that the road was gravelled at some time to serve a house approximately halfway down the range to the reserve. Beyond the previously gravelled section, the road is just two-wheel tracks with evidence that it was cut into the hill and a road formation existed previously. Significant safety concerns would need to be addressed for this section of the access to the reserve prior to allowing any public access.

The road beyond the locked gate is largely unfenced. In some areas it would be very difficult to construct boundary fencing. There is no evidence of fencing on the section of road to the last house but immediately past this house there are fences on both sides of the road reserve to the water reserve boundary. It is uncertain if the location of these fences are on their correct alignment. Fencing of the road would not be absolutely essential initially if the road were to be opened to the public though strongly recommended. A grid could be placed where the current locked gate is located, and appropriate signage could be installed by the landowners warning of stock being in the area. However, this would require an application to Council by the landowners to install the grid and use the road and the risk to the travelling public created by the stock would need to be accepted by Council. Access to adjacent private properties from the road would not be impeded which has been a significant concern previously raised by landholders in opposition to any potential opening of McCauley Weir Road to the general public. Currently the adjoining landowners use the road reserve for access to their properties.

The 2012 report considered capital works required to bring the road up to safe rural standard noting that standards have generally increased requirements over the last ten (10) years. Works recommended at the time were:-

- formation of a road to accommodate two-way traffic with appropriate gravelling particularly in steep areas;
- construction of adequate drainage structures in and beside the formation to ensure that constant scouring of the road didn't occur;
- protection of existing drainage structures and particularly rock protection of the outlets to prevent erosion of the adjoining properties;
- Installation of delineators/guideposts particularly close spaced on curves and sections where major drops occur beside the road. Guard railing may be considered during detailed design processes; and
- Installation of warning signage e.g., speed restrictions, chevrons on curves, steep decent signs etc.

The current estimated cost of the anticipated scope of work has not been assessed.

The previous Nanango Shire Council reportedly considered whether the road could be designated as a Four-Wheel Drive only road to eliminate some of the liability that would be incurred by Council for allowing the road to be open to traffic. The 2012 report concluded designating the road as a Four-Wheel Drive only road would not be a legal reason to allow the road to be of a lesser standard to

that of any other rural road. The road would be used by all types of vehicles even if Council designated and signed the road accordingly and it would not be possible to police the FWD only designation.

Current Considerations

In September 2021, the Infrastructure department received a Councillor request for information regarding the status of McCauley Weir Road and access to recreational uses of McCauley Weir. A chronological summary of recent history of the road was provided with the response to Councillors.

Officers' advice supporting that response identified that on the balance of considerations over at least the last 16 years, Council has on numerous occasions reconfirmed its position to maintain the impoundment and road access closed to the public, despite due consideration as documented in the information provided. Further, officers recommended the continuation of the restriction of public access under previous resolution of Council. A report to Council addressing the potential to open McCauley Weir Road to the public for four-wheel Drive access has recently been requested.


Conclusion

Nanango Shire Council by resolution in November 2005 moved to close the road under section 915 of the then Local Government Act as it had assessed the road as unsuitable for even four-wheel drive vehicles. The road is not maintained and remains unsafe to open to general public use. Considerable capital expenditure would be required to ensure a safe rural road standard is met. Fencing of the road would be recommended in the interest of safety and to reduce adverse impact to adjoining property owners. Fencing would likely impact current stock management practices and stock water supply.

The capital cost of developing the reserve area to support active recreation is considerable and ongoing operational budgets would be required for both road maintenance and to support the operation and maintenance of the recreational facilities and impoundment.

LOCAL DISASTER MANAGEMENT GROUP UPDATE

The Local Disaster Management Group held their quarterly meeting last Thursday 1 September 2022. During this meeting the group were briefed from the Bureau of Meteorology (BOM) in relation to the upcoming season. The BOM advised they predicted wetter than average conditions this year due to the formation of a third La Nina in the tropical pacific.

The LDMG took this opportunity after the briefing to discuss and plan for the upcoming season. The chance of severe storms and weather systems are likely.

We now call on the community to prepare your household and community to protect what matters most and take the pressure off emergency services.

Getting ready for storm season isn't as scary as it sounds. It's as simple as making a basic plan if your pets are home alone, to check on your neighbours, what to do if you're separated from your family members and where to go should you need to evacuate.

Being resilient is about more than just good preparation or effective responding. It is about accepting that extreme weather is part of living in our region, and preparing to handle it accordingly.

9.2 PROSTON RURAL NON POTABLE WATER SUPPLY SCHEME

Proston Rural Non Potable Water Supply Scheme

SUMMARY

The Executive and Finance and Corporate Standing Committee meeting held on 21 September 2022 resolved to seek information in regards to the Proston Non Potable Water Supply Scheme recent disruption.

OFFICER'S RECOMMENDATION

That the committee recommend to Council that:

- 1. The report be noted, and;
- 2. The attached draft Non Potable Water fact sheet be included on councils website and possible inclusion with rates notice for the schemes of Proston Rural, Kumbia and Wooroolin.

REPORT

Proston Rural water supply is a non potable water supply meaning it is unfit for human consumption and should only be used domestically for garden use and toilets. It should never be used for inside domestic use such as cleaning of food preparation surfaces or bathing as there is no treatment process for the water. Customers on this scheme should have dedicated water storage for domestic bathing etc which is either transported potable water or rainwater.

Proston Rural water supply scheme customers are required to have adequate storage to last three (3) days. This requirement is to ensure that should unscheduled water outages occur that there is ample time to find the fault and repair the fault. Being a rural scheme it can be quite difficult locating water main breaks due to the vast distances between serviced properties. The design and layout of the scheme is a historical arrangement.

The scheme recently was subject to a maintenance outage which drew some criticism for lack of notification. Council followed its normal community notification procedure with a media release across its network which is the current practice for other water incidents. Whilst each disruption is an inconvenience they do occur across the network without notice.

In the case of outages on the Proston scheme, the effect of outages should be minimal as the scheme requires customers to hold three (3) days storage at all times. Council received a number of complaints for the outage which can be attributed to residents using the water for potable purposes and also not holding adequate storage, which is of concern.

There was a suggestion that Council should send SMS alerts to the area for outages, unfortunately Council does not have this capability. Council currently only sends alerts from the State Disaster Coordination Centre and are only issued in a disaster situation. If Council wanted to send SMS alerts in adhoc circumstances, it would need to investigate possible software, budget, resources and government approval requirements.

Water Outage Event Tuesday 13 September, 2022

Below email advice to Councillors

Proston and Proston rural supplies. Are fed by raw water pumps off the Boondooma pipeline. 6 weeks ago the main duty pump broke down and was unrepairable so a new pump was ordered.

The new pump is on the docks in Melbourne but not likely to arrive for another two weeks. Today the standby pump has disintegrated leaving us not options but to impose severe restrictions.

Proston rural has been switched off and most landholders notified of the situation. Some may have already run out of water and others may last several days, depends on demand, Hivesville still has water but may run out if the below replacement pump action isn't successful.

Proston town still has supply and is expected with severe restrictions to have 5 days supply before having to cart water.

We would have the ability to cart drinking water for Proston town as their usage is around 100,000 to 150,000 litres per day. We couldn't cart for Proston rural as the requirement would be 900,000 litres per day and their just isn't that many trucks available.

Forward Plan

Our team has identified that we have two booster pumps at Hivesville. We are removing one of these to install at Proston tomorrow.

This pump can pump to the required head pressure but flow volume only delivers about two thirds of the required water, meaning tight restrictions will have to remain until the proper pump arrives.

Logistics

Tuesday Electricians have deenergised the Hivesville pump today

Wednesday Crane truck to Hivesville to remove pump and transport to Proston

Wednesday steel fabricators to Proston to modify the existing pump cradle to fit the pump as it's a different size.

Wednesday water team to hook up local pipework to suit new pump.

Wednesday Electricians to Proston to wire in new pump

I have just spoken to our water supervisor and confirm that the pump replacement has been successful and we are currently pumping water.


It will take a few days to return to full reservoir's but rural properties will commence receiving water tomorrow.

Council have several Non Potable Water Schemes Proston Rural, Kumbia and Wooroolin

What is Non Potable Water?

Non Potable water is untreated water of a quality not suitable for drinking, cooking and personal bathing.

What are some uses of Non Potable water?

Non Potable water can be used for the following:

- toilet flushing
- gardens or crop irrigation
- cooling towers and car washing
- dust suppression and landscape irrigation
- Watering of gardens with non potable water as long as it doesn't come into direct contact with the edible part of the plant.
- Cleaning non-food contact surfaces, such as floors.

What should Non Potable water not be used for?

Non Potable water should not be used for any purpose that might result in the ingestion of water or when water comes into contact with the skin, potable water is used in these instances.

What other arrangements should customers are connected to Non Potable water schemes have inplace?

Customers on these schemes should have dedicated water storage for domestic bathing etc which is either transported potable water or rainwater which is tested as being safe for consumption.
