- ❖ The cost of repairs/maintenance due to failure of the banner and/or ropes will be borne by the applicant
- ❖ The Form of Indemnity on the reverse side is completed and signed by the Applicant/s
- ❖ No political, racial, religious or inflammatory information is to be placed on the banner
- ❖ Payment is required upon lodgement of this application

## BANNER SPECIFICATION

The banner should be constructed of a reinforced PVC material, or material of similar strength approved by Council.

Maximum length of banner	10 metres
Maximum depth of banner	0.8 metres
Minimum rope length (top & bottom of banner)	18.5 metres each rope
Minimum rope diameter (silver nylon rope)	12mm
<b>Eyelets</b> (12mm diameter) are to be provided at maximum 1.0m spacing along the top of the banner	
<b>Air Holes</b> 150mm diameter, to be cut into banner at maximum 1.5 metre spacing
